# **CRAN wins USAID-funded MSI/LOGODEP Project**

Management Systems International (MSI) has awarded a six -month project to the Christian Rural Aid Network (CRAN) under Ghana's Local Governance and Decentralisation Program (LOGODEP).

The Project was sponsored by the United States Agency for International Development (USAID) to be executed in the Shama District of the Western Region of Ghana.

CRAN is to build the capacity of local communities in the Shama district in Communitybased Health Planning and Services (CHPS) concept.

A total of 15 beneficiary communities made up of 10 catchment area communities (Abuesi, Dwomo, Shama-Kumasi, Komfuaku, Bosomdo, Krobo, Bronikrom, Asemasa, Essumankrom and Anapasu) and the five CHPS compound communities (Inchaban, Grabodo, Anlo Beach, Fawomanye, Abotareye) are targeted in the Shama district.

The project dubbed, "Strengthening the Capacity of "Local communities" for Effective Participation in and Management of the Community-Based Health Planning and Services (CHPS) Program in the Shama District" started in February 2012 and would be completed by July 2012.

Activities such as community entry, community sensitization, training for Community health committees, community health volunteers and gender sensitization workshops as well as radio programmes would be carried out to enable community members embrace the CHPS concept.

The introduction of the Community-based Health Planning and Services (CHPS) Initiative in Ghana was as a result of a 1998 study on the Navrongo Health Research Centre (NHRC) performed by the Ministry of Health (MoH) /Ghana Health Services (GHS). MoH/GHS designed the CHPS initiative to improve access, equity, quality, and efficiency of primary health care in support of the objectives of health sector reforms at the community level.

The CHPS initiative seeks to develop community-based service delivery points and improve partnerships with community leaders and social groups in all of Ghana's districts. CHPS has been seen as a mechanism for achieving health reforms at the periphery based on the fact that more than 70% of Ghanaians live over eight kilometers from the nearest healthcare provider; a problem that is exacerbated by inadequate infrastructure.

The CHPS initiative is part of a policy to bridge the ruralurban health equity gap by bringing basic and essential health services to the door steps of the rural poor. The concept aims to establish small health points or units (known as 'CHPS Compounds') in selected accessible villages that can provide adjoining villages and catchment areas with basic health services - a concept similar to the "barefoot doctor" model of Sri Lanka.

In the Shama District, management/steering committees that are to oversee the implementation and management of the CHPS are often not in place and, so lack the capacity to effectively manage the projects in a sustainable manner, hence this project to ensure their existence and effectiveness.

In collaboration with the Shama District Health Management Team, CRAN is hopeful to complete the project on schedule.

# **CRAN Rolls out Brochure on CESS**

**E** fforts at rebranding the Child Education Support Scheme (CESS) to raise the image of CRAN in support of a number of needy children are on course.

After 18years of operation and services to assist needy children in deprived areas to bring them up to a higher level in education, the CESS programme has been given a new image.

A 32-page brochure titled: LITTLE HELPS MAKE A DIFFERENCE with success stories of some beneficiaries, has been published. The compilation is made up of comments from the Board, the Administration, short life-threatening stories of some 10 beneficiaries of the scheme and that of some donors.

The idea is to present these success stories to the public and prospective sponsors.

The brochure together with sponsorship proposal will be presented to the wider public, philanthropists, and organizations, local and international to solicit funds in cash or kind as a show of their social responsibility. This is to cover the increasing number of children who urgently need support for good education. Another goal is, through this colourful brochure compiled by CRAN's Communication and Public Relations Department, to give the world first hand insight into the workings of CRAN CESS programme.

The Public Relations Department of CRAN hopes to compile stories of more children to be published for the benefit of both donors and the public as well as to seek more support for the beneficiaries.

The Christian Rural Aid Network (CRAN) has submitted the 1st Quarter report on the Rice Sector Support Project (RSSP) to the Crop Services Division of the Ministry of Food and Agriculture.

The rice sector support project (RSSP) was initiated by the government of Ghana through the Ministry of Food and Agriculture (MoFA) with major support from the French Development Agency/AFD (Agence Francais de Development) and being implemented in four regions namely Upper East, Upper West, Northern and northern part of Volta across 19 districts in the selected regions.

The project which seeks to increase the volume of rice production and to reduce poverty is targeting the rice value chain actors (RVCAs) including: farmers, processors, marketers and input dealers whose capacity are to be built and strengthened for sustainability through service provision by non-governmental organizations (NGOs), Ghana Rice Interprofession Body (GRIB) research institutions, Non Formal Education Division (NFED) among other stakeholders.

The Christian Rural Aid Network (CRAN) is the NGO providing capacity building service to RVCAs on RSSP in the Volta Region. This current report covers the period January -March (first quarter), 2012, and it highlights CRAN's activities carried out and the outcomes during the period.

The project seeks to increase food security, reduce poverty and strengthen rice value chain in targeted regions/districts.

It further seeks to support the rice value chain through – land reclamation; facilitate access to credit for stakeholders; build the capacity of stakeholders; employ adapted research experiments on rice production, processing technologies and farming systems and also enhance the national organization of the rice sector (support for GRIB) etc.

A number of farmer based organisations as well as processors, marketers are expected to be identified, organized and equipped to operate effectively in value chain in all targeted areas.

As part of the project implementation, CRAN is also expected to liaise with & support other stakeholders (NFED, MoFA etc) to provide functional literacy & numeracy training for targeted beneficiaries.

So far about 300 beneficiaries (comprising 161 females and 132 males) were trained in Conflict Management; Group Dynamics; Entrepreneurship; Business Planning; Record Keeping; Safe use of agrochemicals; Cultural practices of rice farming. Therefore, coherency in groups boosted; skills/ knowledge of BOs enriched for better performance.

CRAN is collaborating with MoFA, AFRICARE and some Rural Banks in Hohoe to educate the RSSP project communities on MoFA's development plans for the Hohoe district.
