At long last, the gari and corn mill project in the Ndasimam community has been completed, ready for commissioning. The project which begun in June has been completed in seven months. The GHC 30,300 project has two main units. The first is the building which contains the machines – thus the corn mill as well as the cassava grater. These are two separate machines which have been established in the main building. The second aspect is the construction of the shed under which the cassava dough will be roasted into gari. All these aspects of the project have been completed and ready for full operation. We thank the German Embassy in Ghana for the trust the put in CRAN in giving this support for the people at Ndasimam and we hope that this collaboration will continue into the future.

CRAN Wins Proposals

CRAN being a local NGO with an international partner, depends a lot on support from the donor partners to continue with its mandate to the target beneficiaries. By the Grace of God, CRAN has been successful with assessment of two funding support. The first funding is coming from the Ghana Aids Commission (GAC). The five-year project will focus on non-clinical HIV prevention activities towards the target societies with the aim of meeting the 90-90-90 Global Agenda set by the UNAIDS. CRAN has been chosen to spearhead the achievement of this goal in the Central Region. The second has to do with a funding support from the French Embassy through the West Africa Civil Society Institute (WACSI) an organization committed to strengthening the capacity of civil society organizations so that they will be able to perform to the optimum. The rolling of these projects will likely begin in the first quarter of 2017. We thank God for the opening doors.
