WACSI ORGANIZES TRAINING WORKSHOP FOR CSOS

The West African Civil Society Institute (WACSI) has organized training workshops for civil society organizations (CSOs) in which two of CRAN staff took part. This forms part of their efforts to strengthen civil society organizations in the country. WACSI has a broad aim of building the capacity of CSOs through training of their human resource to enable them perform their roles more efficiently. The training workshops were organized separately for the Managers and project officers of the CSOs. The first training workshop which was a two-day programme was organized for the Managers of the CSOs on leadership and governance. This came off from the 27th-28th of February 2017 at the WACSI office in at East Legon, Accra. The second training which took place at the same venue for the project officers was on result-based monitoring and evaluation from the 1st-3rd of March 2017. CRAN's Head of Administration attended the workshop on governance and leadership, while the Project Officer attended the one on monitoring and evaluation. These form the first batch of series of training set for all the CSOs which have receive approval by WACSI to undergo series of training to enable them build their capacity. CRAN is hopeful that the skills and lessons learned from these workshops will go a long way to strengthen the organization.

CARI EXTENDS CONTRACT WITH CRAN

The Competitive African Rice Initiative (CARI) contract with CRAN has been extended until March 2018. The initial contract which came to a close at the end of November 2016 has been renewed by the funders - GIZ. CRAN is very grateful for the gesture.

Earlier, CARI and its stakeholders met in an end of project briefing where the issues bordering the first contracts were discussed.

The first contracted ended with a good success. CRAN was able to support four thousand and sixty-one (4,061) farmers in the rice sector in the target communities. The project exceeded its target by sixty-one farmers. Out of this number 69% of them were women. The yield per hectre improved from 2.5 metric tons to 3.5 metric tons. The farmers are very happy for the intervention of CRAN as this business which has been their main occupation has been difficult to carry through over the years. CRAN among other things, prepared the ground for them with the bulldozer, clearing the stamps and removing obstacles, and leveling the ground for easy cultivation. CRAN also gave them adequate training on how to cultivate the rice. The farmers were also well monitored by the CRAN technical staff to ensure that they were following the guidelines given them. The combination of all these efforts led to the success we have chalked. It is therefore not surprising that CARI has decided to extend the contract. The extension will benefit the farmers greatly as they look forward to the continual support from the technical team of CRAN.
