More Investors show interest in CRAN Microfinance

A number of foreign investors have expressed their interest to invest funds into the operations of CRAN Microfinance.

Their attraction to the work of CRAN Microfinance was due to the organisation's commitment to alleviating poverty among rural dwellers in parts of Ghana, especially in offering opportunities to women to develop themselves and provide livelihood to their families.

Among those who paid visit to assess the financial performance of CRAN Microfinance and its impact of rural women in particular include Alterfin, a cooperative society of North South organisations in Belgium, and ADA Microfinance Expertise.

In a 3-day working visit to CRAN Microfinance from November 28th-30th 2011,

Ms Diana Banuro, Financial Analyst of Alterfin, expressed her organisation's desire to invest in a socially-oriented microfinance organisation

like CRAN MF.

The visitors were taken to the field to familiarise themselves with CRAN MF's field work and assess the impact of the loans on the lives of the rural women who form about 80% of CRAN Microfinance's clients base.

The CEO of CRAN MF, Benjamin Turkson, in an address said that CRAN MF and Alterfin have a common social goal of alleviating rural women especially of poverty and so Alterfin's desire to invest in CRAN MF was in the right direction to give hope to the rural dweller.

He expressed the hope that by the time CRAN MF and Alterfin conclude discussion on the investment, an amount of five hundred thousand dollars would be invested into the operations of CRAN MF.

CORDAID rolls out Bail-Out plan for CRAN MF

CORDAID's Africa Investment Officer, Annemieke Van Der Leij, had paid a three-day working visit to CRAN Microfinance to ascertain the current operations of CRAN MF as prescribed by the demands in the new agreement between CRAN and her donors.

The visit took place between September 23rd and 25th, 2011 and was meant to provide information to the donor about the current

operations of CRAN Microfinance as well as lend further support on its development agenda of providing livelihood to the rural poor in parts of Ghana.

Among other things, Ms Van Der Liej's visit was to confirm the bail out plan for CRAN Microfinance out of the financial crisis it has suffered for the past two years.

CORDAID has therefore supported CRAN Microfinance with a 2-year interest-free loan of €125,000.00 and a donated equity of €150,000.00 meant to relieve CRAN Microfinance of its operational cost and expenses.

At the end of the visit during which she called on some clients at their meetings, Ms Van Der Leij expressed confidence in the operations of CRAN Microfinance and stated CORDAID's resolve to continue to support the operations of CRAN Microfinance.

She was however emphatic on CORDAID's main objective of providing support to the rural poor, insisting that CRAN Microfinance should roll out its loans to improve the lots of the rural poor in the Ghanaian society.

CRAN Acquires Property for Head Office

THE legal acquisition of a two-storey building situated at Pedu, a suburb of Cape Coast, has set the tone for the fulfilment of one of the goals set out in the 2005 - 2015 strategic plan of the CRAN.

A professional architect, Mr. Ebenezer Botchey was contacted to redesign the building for office use.

Artisans have thus began working on the building which will house eleven offices including a conference hall, reception, washrooms, kitchen, an archive and a large parking space.

The renovation is expected to complete in July 2012 for occupancy.

CRAN's corporate image is tipped to improve by the new head office and also give staff enough space to work conveniently.

Plans have been concluded to name the new building after Hans Wallhausser, first coordinator of CRAN Germany who died recently.

Until his demise, Mr Wallhausser was regarded as the kingpin in the beginnings and one who sustained the work of CRAN Germany and CRAN Ghana.
